  - Unit now serves around 50 active PIs per year, nearly double from two years ago, and administers around \$10 million in active faculty research awards per year, also nearly double over the last two years

  - Organize campus-wide and public-facing symposia and events that spotlight interdisciplinary social science research on key issues—including virtual public social science forums on COVID-19 and cross-college conversations on anti-racism and actions for social justice

  - Developed internal funding opportunities for faculty and students and established social science faculty workgroups
  - Facilitate faculty external grant/proposal preparation; spearhead annual college-wide partnership with grants firm Hanover Research
